Wachay! Fox Lake Ney-hwee-nee-no-wuk! O KI MA'S REPORT

Chapleau Cree stands tall and works together with their leadership and administration to functionally make decisions in regards to governance, resources management, the homelands, and surrounding issues. Chief and Council work diligently on implementing and supporting community projects and development. It has been with the ultimate due diligence that I provide you with an update in this newsletter.

Spring is a very important season in the circle of life. It is the time where the long winter has come to an end, and the people are coming off the trap lines to do their spring harvesting. Spring is represented by the east, the colour yellow, youth and children. It is a time when new life begins.

Chapleau Cree has been going through negotiations with Goldcorp for some time now. Recently Goldcorp has agreed to all of our terms in general. However, we are ironing out the details on July 4^{th} , 5^{th} and 6^{th} at the Olthuis Kleer Townshend (OKT) law office in Toronto. Everything should be finalized in the months to come.

February 2017: Representatives of Indigenous and Northern Affairs Canada (INAC) present Chief Corston with a letter confirming their commitment to the construction phase of the water plant project – a \$3.9 million upgrade.



Chief's Report - Cont'd

Recently, the Chiefs made a motion to remove existing Kunuwanimano board members and temporarily replace them with the Chiefs. However, we learned through the bylaw that it was not achievable. Therefore, Chapleau Cree has temporarily placed Deputy Chief James Fletcher in this position.



We are engaging in a process to develop our land code. This process is defined as the First Nations Lands Management Frame Work (FNLMF). It is a very exciting project that will be funded through Indigenous and Northern Affairs Canada (INAC). The goal of this process is to remain autonomous on our reserve and traditional lands. It gives us the authority to plan and govern our lands as this is our right under the constitution of Canada.

The native studies class from Chapleau

High School joined us in the turtle lodge for some history on Chapleau Cree First Nation. The turtle lodge was the appropriate place to do this. I spoke to them about treaty rights, the history of Chapleau Cree, and who we are as a people. I always encouraged this kind of partnership with the municipality of Chapleau to educate the non-native people on our history and our constitutional rights.

Chief's Report - Cont'd

I believe this educational piece is very important, so the general population is not misled by the government distorting the truth. Education is such a powerful factor in life. It teaches the people they do not need to consider us foe, and it builds great allies in our quest for social justice, and to take our rightful place on the land, as intended by the grandfathers in the treaty.

As stated in the previous newsletter, there were four band members that were missed in the last round of negotiations. Recently, I negotiated with the federal government on the loss of use monetary piece. The federal government figure of five hundred and twelve thousand dollars was grossly inadequate. Through very persuasive arguments by myself and the law firm, we managed to negotiate an extra one hundred and fifty thousand. These details will be ironed out in the coming months. We will be doing

some disbursement on the old formula that was ratified by the band membership last year, which is 77 percent pay out. I will keep you posted as things progress.

We have ongoing negotiations concerning our half ownership in one of the four dams on Kapuskasing River with Hydro Mega. I feel that Chapleau Cree was somewhat exploited in that agreement. I will succeed with better terms in this arrangement.

The two houses are 95% complete. The housing committee is now taking applications. These two homes are not your typical box house, but have a bit of character. We are

already thinking of building more houses as it is very evident the need is there. With ongoing needs and growth of Chapleau Cree, we are focusing on the first nation's market housing fund to participate in the credit enhancement facility of the fund.

Allan Dupuis currently holds the position of Public Works Manager. Matthew Dupuis has joined our team for a 32-week program sponsored by Mushkegowuk Employment Training Services as our Records Management Clerk.



We have an active Joint Health and Safety Committee. We have updated and implemented our Health and Safety Policy and all staff have received the required training to ensure we comply with the Occupational Health & Safety Act. Upon completion of all required tasks, we applied for a 5% discount on our annual WSIB premiums.

Emergency Response Planning training is being provided through Ontario First Nations Technical Services for our community. This training comes at an opportune time as we are currently updating our emergency plan.

This nomination is made by fellow employees in an anonymous manner and submitted for selection via our suggestion boxes. We proudly post these on our website.

With summer fast approaching, students have begun to look for summer employment. I am happy to report Chapleau Cree has been approved for funding for various positions and encourage all students to apply. Our job postings can be viewed online at www.chapleaucree.ca.

Our Audit was completed in May by KPMG and all programs and requirements have been reported on as per funding guidelines.

We have updated our Housing Policy and it will be available for review by Band Members via Google Docs in the near future.

The construction of our two homes are coming along nicely and should be ready within the next few weeks. The homes have a garage with a deck off the kitchen. They are nicely

designed with a full basement. Please, feel free to drop by the worksite and take a walk through.

We still have a vacant one bedroom apartment available for rent at Mukeso House for band members. Rent is currently set as \$300.00 monthly plus hydro and satellite fees.



We have implemented the Land Use Committee. Their first official meeting was held on June 13, 2017. Any land use questions or concerns can be sent to their attention at the office.

Demolition is being planned at the Golden Route. We are currently waiting for funding approvals before we move forward on the plans to construct an Eco Lodge. We have started the process to remove cabins currently on the property to be removed by interested band members on a first come first served basis. Cabins can be removed from the property at the individual's expense. A gate has been constructed



to restrict access to the boat launch, due to liability. Access will be permitted to band members only.

Our CCFN Kid's Fish Derby had another successful year. There were 29 children in attendance and one fish was caught. Thank you to all our volunteers and supporters! Without their help this event would not have been as big of a success as it was.

Our Youth Champion Amara Ruffo has requested to have a Youth Group formed in our community. We have accepted her request and we look forward to working with our Youth. Thank you Amara.

Water Treatment Plant & Public Works Department

Greetings everyone,

We have had a busy past few months here at Chapleau Cree First Nation. We are still working on the Water Plant upgrade project. We have now completed the 90% design phase and are now awaiting approval from INAC to bring this project to tender. Once this stage is finalized we will be able to secure a contractor and get shovels in the ground. This project has been a lot of work by many different people and our goal of clean, safe, potable water should be realized in the near future.

Our First Nations Water and Wastewater Action Plan program is nearing completion. This was a program that was sponsored by Health Canada. The criteria for this program was to complete water sampling as well as to provide cultural appropriate events that emphasized on safe drinking water. Cheryl Cachagee worked with me at the Water Treatment Plant from January to the end of March. She coordinated a Full Moon ceremony, completed a community survey to identify



important lakes and waterways, co-hosted a community information session and planned a kids event with water games and teachings which will take place on Aboriginal Day. Taking water samples, flushing hydrants, or hosting outdoor events



during the coldest months of the year is a difficult task but Cheryl was always in high spirits and enthusiastic and I would like to thank her for her work on this program.

Our new Public Works employee Eric Caldwell has been training in the Water Treatment Plant to become a certified operator. He attended an AWWAO conference in Sault Ste Marie where he wrote and passed his mandatory entry level course through the Walkerton Clean Water Center. Next,

he will work towards completing his Operator-in-Training (OIT) certification. Eric has been making excellent progress so far and I look forward to having another certified operator at the Chapleau Cree Water Treatment Plant.

Our Public Works department has been busy throughout the cold season with plowing, salting, sanding, shoveling, wood, home health care programs, as well as staying on top of the day to day maintenance issues at Chapleau Cree First Nation. We are all happy to see that spring is here to stay and we can now shift our focus away from winter and onto other projects.



Our team completed a Canada Mortgage

and Housing Corporation (CMHC) sponsored building maintenance and inspection course as well as a Safe Propane Handling certification. We still have training and



certification goals we plan on completing and I look forward to updating you in the future on our progress.

In the next few months we have our work cut out for us. We have our yearly spring clean up to complete, weekly events and dinners to help setup, our Aboriginal Day festivities as well as the Kids Cultural Camp and yearly Pow Wow. All departments are working on Health and Safety policies and procedures, ensuring that

Chapleau Cree First Nation is a safe place for everyone to work. We are currently putting together a plan to address the issues outlined in our latest Asset Condition Reporting System (A.C.R.S.) report for building deficiencies. I will continue to keep you, the members of Chapleau Cree First Nation and its residents posted on our progress in our newsletters.





The Mushkegowuk Economic Summit was held in Timmins where leaders and economic development officers participated in a regional planning session to identify what the model could look like as a support mechanism for the member communities.



My take away was to ensure that competing interest for business development should be supported and shared throughout the regions as we all have our own priorities. There are still common goals where we can partner and develop for growth and prosperity together. The Report has

Chapleau Cree Eco Tourism Lodge

NOHFC, Northern Ontario Heritage Fund Corporation meetings with Bruce Strapp, General Manager has been ongoing to support the applications required for Chapleau Cree Eco Tourism Lodge. There is ongoing dialogue set out for capital purchases, marketing and promotion for the Chapleau Cree Eco Tourism Lodge formerly known as Kathy's Kitchen/ Golden Route. Two applications are in progress for the accommodations piece. The theme for the community conference centre is the seven lodges to reflect the Big Bear Teachings and/ or seven grandfathers. The designs/briefs are to be reviewed, prior to submission. JL Richards engineering has provided us with a scope of work.

I attended the Waubetek Business Development regional conference that shared some excellent business development themes and supports. My takeaway was the networking and gathering of resources useful to business development practices for the Chapleau Cree Eco Tourism Lodge.

Chapleau Cree hosted a Funding Forum to identify funds, deadlines, overlapping applications, and local community priorities. The funding agencies that participated were FEDNOR, NOHFC, NWMO, INAC, regrets were MIRR, Trillium, and NADF. The day was welcomed by opening remarks by the Chief at the Turtle Lodge.


The demolition application for Golden Route was submitted early this year to get the activity going at Sideburned Lake. The demolition will consist of the removal of all infrastructure currently there but band members are offered the chance to salvage and remove any building they are interested in on a first come, first served basis. The Land Use Permit has been transferred to Chapleau Cree First Nation and will be included in a future Addition to Reserve application.

The Devon aggregate pit management agreement has been renegotiated and Miller paving has been renewed for the royalty management. Through this partnership Chapleau Cree gains to work together with Miller Paving for aggregate contracts with Ministry of Transportation, Borden Gold, and the Town of Chapleau.

Most recently, Chapleau Cree coordinated and hosted a meeting in the community where MTO/MNRF discussed aggregates, the duty to consult process, and applications for pits in the area. The final outcome was the involvement of stakeholders including ACE

Contracting, Missinabi Headwaters, Milman Industries, the Three First Nations joint venture, the Ministry of Transportation, and the Ministry of Natural Resources. A legal opinion was drafted for this event explaining the duty to consult, territorial use, and traditional ecological knowledge protection.



Education – Stephanie Scott

Congratulations to all 2017 graduates from Pre-School to Post-Secondary School!

Chapleau Cree has received quite a few Post-Secondary applications this year. Unfortunately, due to limited funding, Chapleau Cree was only able to fund 15 full time Post-Secondary applicants for the upcoming 2017-18 academic year. INAC has not increased the Post-Secondary budget for quite a few years so it is extremely important when applying for Post-Secondary funding to have it in before the deadline to ensure it qualifies and meets Chapleau Cree First Nation's funding criteria. Please keep in mind, it can take six to eight weeks to process your request allowing for the timing of the Education Committee and Chief and Council meetings. Please plan accordingly.

I encourage all Post-Secondary Students to apply for bursaries and scholarships that are available, especially those specifically for Aboriginal students. Indigenous and

Northern Development Canada (INAC) has an Aboriginal Bursaries Search Tool available on their web site. The Aboriginal Bursaries Search Tool is comprised of a list

of more than 750 Bursaries, Scholarships and incentives across Canada, being offered by governments, universities and colleges, private and public companies, individual Canadians, organizations and others. The majority of bursaries on this list target Aboriginal students but could vary by group such as a First Nation, Métis or Inuit. Also, some bursaries are specific to a region, place of residence, a school, or a field of study. This tool is found at the INAC website http://www.aadnc-aandc.gc.ca/eng under the "Education" tab, "Post-Secondary School" sub-category.

OSAP has recently made a few changes regarding Indigenous learners. OSAP will no longer include Post-Secondary Student Support Program dollars (Band Funding) as a resource, meaning the student will no longer be penalized dollar for dollar. The student contribution amount that was previously taken off the top of the loan/grant to the student will no longer be applied and will be waived to self-identified indigenous students. If you were to use the OSAP estimate calculator on the website, the calculator does not allow for the waived amount therefore you will have to add the student contribution amount of three thousand dollars to get a more accurate estimate of eligibility amount in loan/grant funding.

Several projects have been submitted and approved for funding under Indigenous and Northern Development Canada's various program proposals. These projects include a monthly Reading Hour, After-School Homework Club (with tutor) and Turtle Lodge Teachings also a newly added Youth Movie Night.

Membership Report - Stephanie Scott

In August 2015, The Supreme Court of Quebec rendered its decision in the Descheneaux case. The court found numerous paragraphs and section 6 of the Indian Act have differential treatment of eligibility between Indian women and Indian men along with their descendants. The court's decision also advised that the legislative amendments address all the inequities in the Indian registration not only specific facts from the Descheneaux case.

The proposed amendments under Bill S-3 addresses the inequities identified in the Descheneaux decision and other known sex-based inequities in Indian registration:

- Cousins Issue: Address the differential treatment of first cousins whose grandmother lost status due to marriage with a non-Indian, when that marriage occurred before April 17, 1985.
- **Siblings Issue**: Address the differential treatment of women who were born out of wedlock of Indian fathers between September 4, 1951 and April 17, 1985.
- Issue of Omitted Minors: Address the differential treatment of minor children, who were born of Indian parents or of an Indian mother, but lost entitlement to Indian Status because their mother married a non-Indian after their birth, and between September 4, 1951 and April 17, 1985.

Parliament has until July 3, 2017, to enact legislative amendments under Bill S-3 in order to eliminate the sex-based inequities in Indian registration.

Following the passage of Bill S-3, a collaborative process on the broader issues relating to Indian registration, band membership and citizenship such as;

- Other distinctions in Indian registration
- Issues relating to adoption
- The 1951 cut-off date for eligibility to registration specific to Bill C-3
- The second-generation cut-off
- Unstated/unknown paternity
- Cross-border issues
- Voluntary de-registration
- The continued federal role in determining Indian and band member under the Indian Act
- First Nations authorities to determine membership under the Indian Act.

This phase will take 12-18 months, after which the Minister will take the results of the process to Cabinet.





The efforts of Wahkohtowin to build and identify pathways to full participation in the Forestry Sector is also tied to the Northeast Superior Chiefs Forum mandate to have its First Nations directly involved in the enhanced Sustainable Forest Licence process that will see the Martel and Magpie Forests amalgamated and a shareholder governance structure that

includes a roll in forest governance and management. This is a marked change of rolls and relationships since the 1995 Crown Forest Sustainability Act came into effect.

The current shareholder document places our First Nations able to direct forest management and governance at a higher level, access overlapping license's to grow harvesting enterprises, establish a sustainability and diversification fund resourced by the wood consumers and be in a priority position to take up unutilized or unallocated wood for new opportunities.

Our project efforts last year resulted in many products and outcomes.

Wahkohtowin continues to apply for funding that will continue to organize and support the forming of a Guardianship Program designed in part as fee for service opportunities with area Forest Sector partners and act as a catalyst for career development pathways for our youth. This program is designed to support a direct relationship with youth and elders putting people on the land to monitor and provide a stewardship roll.

We thank everyone for your patience as our website is still under construction and should be available shortly. This website will serve to act as a library for the past 10 years of NSRCF work and showcase the go forward business development and key projects that our shareholders – our First Nation owners deem important.


