Wachay! Fox Lake Ney-hwee-nee-no-wuk! O KI MA'S REPORT

Just as many of the animals prepare for Mother Earth to take a well earned winter rest by building up their food stores, the Chapleau Cree First Nation leadership is gearing up for a hard autumn push to move our community forward before taking a break over the holiday season.

In July, we completed a three-day canoe journey following the path our ancestors took from Chapleau to Racine Camp. This was an important way to show younger generations our way of life. We felt the presence of our ancestors throughout the entire trip.

Our 24th Annual Pow Wow, pictured above, was a great success and I would like to thank everyone who came together to make it possible. The weather was cooperative and it was great to see so many youth participating in traditional dancing and teachings. Next year will be a milestone as we gather for the 25th year and celebrate our traditions together.

Chief's Report - Cont'd

In August, Chapleau Cree came to an agreement with Dr. Doris Mitchell to build a clinic in our community. It will be located across the road from the Health Centre, which is why the playground equipment was moved to be closer to the outdoor rink. Our nation will be well served by having more medical services available in our community. This is also a business arrangement that will give Chapleau Cree ownership of the new building at no cost to the community.

I also attended the Treaty 1-12 Gathering in Taykwa Tagamou Nation. It was a wonderful gathering with many good speakers and Creefest entertainment. These meetings reminded me of the importance of never forgetting the substance of the Treaties and to keep in mind that Treaties are internationally defined as legally binding agreements between two nations.

I have been meeting with Goldcorp in our negotiations for benefits from the Borden Gold project. I have insisted we meet regularly, roughly every six weeks, to make steady progress. We hope to reach an agreement soon, which will need ratification from membership. The Supplementary Treaty Land Entitlement process is moving forward. In the Settlement Agreement last year, the Government of Canada missed four dateof-treaty members that should have been included in our calculations. If they had been included, the loss-of-use payment would have been higher. When this came to light, Canada offered to make a supplementary TLE payment for the missing amount. We expect to receive Canada's official offer letter shortly, after which there will be a vote on whether we will accept this supplementary settlement. This is money that should have been included in the original settlement, so all the same information, processes and considerations will apply. More information will be provided when it becomes available.

In September, I met with the Ontario Minister of Indigenous Relations and Reconciliation David Zimmer and Regional Chief Isadore Day at the Band Office. We talked about the Ontario government's claim of working on a new relationship with First Nations. They recognize First Nation issues, such as water quality, and are looking to bridge the gap. I expressed the need for meaningful input – drafting and creating the policies that impact our people.

As we know, our native rights to trap and hunt for sustenance come with a responsibility to ensure animal populations are healthy. I humbly and respectfully ask members to refrain from shooting cow and calf moose to prevent further damage to the ecosystem. Enjoy your hunt and be safe.

Administration has been very busy working alongside the various departments, government agencies and funders to ensure the services and activities we provide are meeting the needs of our members.

Administration has been working on our Housing and Administration Policy these past few months. This process is taking longer than anticipated as we are taking the necessary steps to ensure members and employees have an opportunity to share their concerns for consideration prior to accepting the new policies. Our housing policy will be made available on our website in the next coming weeks for those who would like to review and perhaps make some suggestions.

We are currently in the process of changing our application forms to a digital format. As these forms are completed we will upload them to our website for band members convenience. These documents are made available to our registered members only and you must have an account to access them. Please visit our website www.chapleaucree.ca for further information.

Our Public Works department has been busy with the regular maintenance and upkeep of all of our buildings and lands. The Public Works department works hand in hand with all of the departments to ensure their programs are running smoothly performing any manual labour when the need arises.

The Health Centre has had some major renovations completed this past summer. All of the work is complete and Maamwesying is now open to serving interested members. The Health Centre continues with programming and services for all our band members and their families. Please see the monthly community calendar if interested in participating in any of their events.

Our Education department was busy with recent graduates from Elementary, Secondary and Post-Secondary programming in addition to getting our students ready for another academic school year. Congratulations to all of our members who have graduated and good luck to those students who are continuing on with their education.

Economic Development continues to meet with our members monthly keeping them informed on current and future projects. Our Economic Development Officer, Patty Ann Owl, is currently on a modified work schedule and is available at Chapleau Cree First Nation on Mondays only.



Patty Ann Owl will return to her regular schedule work week the second week of December. Stephen Lee, Communications will assist with any projects requiring attention while Patty Ann is away on approved leave.

Our businesses, Pimii Kamik Gas Bar, Chapleau Cree Auto/ Truck and Chapleau Cree Small Engines continue to operate during their regular business hours. Chi Bannoch has closed for the season, sadly a sure sign winter is on its way soon.

Administration continues to hold monthly meetings with our Managers and Staff. Information shared during these meetings allows us to better serve our employees and members of our First Nation. We have also installed suggestion boxes at various departments and encourage employees and members of Chapleau Cree First Nation to submit their concerns and ideas to administration in a confidential manner. Suggestion boxes are secure and are checked on a monthly basis.

Our summer student job training positions are now complete. We would like to thank all of our employees who joined us for the summer. We hoped you enjoyed working with our First Nation and wish you all good luck in your future career goals.

We welcome Kimberly Ruffo as she has recently joined our team. Ms. Ruffo's positions is funded through Mushkegowuk Employment and Training. Welcome aboard Kimberly. We all look forward to working with you and making your training a rewarding and truly enjoyable experience.

Employee of the Month is in place to celebrate a co-worker who has gone above and beyond the scope of their job duties in the workplace. The following are the past winners, which are proudly posted on our website:

As required by the Ministry of Labour, we now have an active Joint Health and Safety Committee. The Committee meets once a month to ensure employees are safe and are following Ministry of Labour requirements. The Committee continues to do great work in ensuring all of our staff have the necessary training required to keep all employees protected and safe on the job. Ontario First Nation Technical Service Corporation has been providing the necessary training for four participants in the area of Emergency Response Planning. This training is of great importance when it comes to Emergency Preparedness. With the recent natural disasters and extended power outages, the need for an up to date Emergency plan for our First Nation exists.

Our two homes are now complete and are ready for occupancy. Our new tenants Cheryl Cachagee, and Joshua Raposo are officially moving in on October 1, 2017. I would like to wish them and their families a warm welcome to our community.

Mukeso House currently has a one-bedroom apartment available for rent. Rent is currently set as \$300.00 monthly plus hydro and satellite fees. Any band member interested in applying, please call the office for further information.

Construction for a new medical clinic has begun on Fox Lake Road. Dr. Doris Mitchell will be leasing the new building and has signed a lease with Chapleau Cree First Nation. We are also working on a joint venture with Dr. Doris Mitchell to use a portion of the new building as an exercise facility. Kristopher's Adventureland has been relocated to Cachagee Road and is conveniently located next to the outdoor rink.

Demolition plans for Kathy's Kitchen/Golden Route location is still in the works. We have submitted an application to cover the costs and are currently waiting for approval. Our second annual harvest is scheduled for October 12 - 15, 2017 at Racine Lake. Chief and Council continue to support this initiative to promote our cultural heritage with many of our teachings being facilitated by our own members and staff. This event is open to all of our members. Please feel free to drop in and join us in our activities. Once activities are finalized a schedule will be available on our website for interested members.

We are looking for volunteer members to sit on our newly developed "Social Committee". Anyone interested in sitting on this committee to help plan and coordinate

The Economic Business initiatives include business retention, promotion, marketing and expansion. Education – Stephanie Scott

The new school year has begun; it is a busy here in the office. This year we are funding 15 full-time students for post-secondary studies.

Several projects have been funded under Indigenous & Northern Affairs Canada including; Reading Hour, After-School Homework Club (with tutor), Turtle Lodge Teachings, Youth Movie Night and Youth Bingo. Also, for the past few years the Education Department has given away free books to children from birth to 18 yrs old to promote literacy in the home.

Band Members can access Mushkegowuk Employment & Training Services (METS) which provides funding for individuals through a combination of programs and services with the goal of improving the applicants' employment skills to facilitate their entry into the labour market. Applications for funding are available at my office or via Clara Wheesk, Community Development Officer at 705-268-1150 or email clarawheesk@mushkegowuk.ca.

METS provides funding for:

- * Programs, courses and training opportunity of one year or less;
- * Programs, courses and training that provide direct entry into the labour force;
- * Course costs & materials, books & supplies, income support, travel, accommodations;
- * Pre-Employment Support such as travel costs for interviews;
- * Mobility relocation costs for employment;
- * Licences, certificates etc. needed for employment.

It is important to note that funding is limited and that the process may take six to eight weeks depending on the amount of funds requested. Applications are submitted directly to METS and not to my office. I work hand in hand with METS Community Development Officer to aid CCFN applicants in accessing funding for education and training purposes, often sharing the cost between METS and CCFN's RAMA Education Program (must apply to CCFN for this program) and Ontario Works (if applicable).

For those who would like a career in the trades, information on apprenticeship programs is available at www.tcu.gov.on.ca. Apprenticeship funding for CCFN Band Members is coordinated between CCFN, METS, MTCU and Ontario Works (if applicable) to ensure that the applicant receives the best possible funding available.

Info for Band Members on Nuclear Waste

Nuclear waste is left over when electricity is produced at nuclear power plants. This radioactive waste is hazardous for thousands of years.

The Nuclear Waste Management Organization (NWMO) is a non-profit corporation funded by Canadian energy companies to manage Canada's nuclear waste.



The NWMO is currently trying to choose between

several locations for storing nuclear waste. The locations are Blind River, Elliot Lake area; Hornepayne area; Huron-Kinloss; Ignace area; Manitouwadge area; and South Bruce, Ontario.



When NAN reviewed the NWMO process in 2005 they found it went against the United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP) which says: "States shall take effective measures to ensure that no storage or disposal of hazardous materials shall take place in the lands or territories of indigenous peoples without their free, prior and informed consent."

In response, Chiefs of the Nishnawbe-Aski Nation (NAN) passed Resolution 05/57 declaring NAN a Nuclear Waste Free Zone.

In 2016, Chapleau Cree First Nation requested and accepted funds from NWMO that will be used to inform band members about nuclear waste. Chief and Council also prioritized using these funds to promote cultural **26** renewal through traditional activities and being on the land.

Membership Report - Stephanie Scott

Bill S-3 went through its third reading with the Senate on June 21st, unfortunately the House of Commons did not vote in favor. The bill was sent back to the Senate with revisions. The Senate has since requested yet another extension and was denied by the original presiding Judge. It was appealed and granted a 5-month extension by a Quebec court giving them until December 22nd.

For those of you who have not been in Chapleau to collect your Treaty Annuity Payments, you may do so by completing the Treaty Annuity Payment form found online on the AANDC website http://www.aadnc-aandc.gc.ca under "Benefits and Rights". Scroll down and select "Forms"; the Treaty Annuity Payment form is the very last one listed. Send the completed form, along with a photocopy of your status card (front and back) to the Ontario-North Lands and Trust Services in Thunder Bay. The full address is listed on the form. It is important to note that you must submit this form every year to receive your payment. If you have not received a payment in a few years, they will issue you payment for previous years!

Whachay whachay!

This is Kyle Corston with the CCFN culture update this October, or Rutting/Freezing Moon. As summer comes to an end, we transition into harvest season and get ready for the coming winter months. We had what seemed to be a short summer, with lots of rain and cloudy days; but it's been good for the Tree and Plant Nations, and for the Medicines out on the land. At present, we are getting ready for the second annual Community Fall Harvest, which will be held at the Racine Lake campground from October 12th-15th. The geese are flying, moose are getting ready to rut, and everyone is excited for the hunt! We hope to see as many community members attend as possible, with workshops and events planned throughout the 4 days and country foods out on the land as our ancestors enjoyed.

We had an eventful past few months, which started off with a renewal of the Turtle Lodge in the spring-time. Martin Millen assisted with the fasting and feasting of the Turtle Lodge bundle, as well as assisting Cheryl Cachagee who performed a water ceremony on Borden Lake. We were instructed prior to this, in an Ancestry Feast with Jules Tapas, that the ancestors were requiring us to perform a ceremony on Borden on a site where our ancestors used to camp a long, long time ago. Cheryl, with the help of Martin Millen, Dustin Van Horne, and Kyle Corston, made an offering to the lake which included tobacco and a copper vessel. Martin Millen also helped put together written protocols for the Turtle Lodge that are being reviewed by CCFN staff.

In July, we ventured out on our first annual community canoe trip. A group of 16 of us departed from the back river (Nebeskwasheshing River) in Chapleau near the "Indian Bridge", and canoed 35 kms to the Racine Lake campground. The resulting 3 days was an amazing and unforgettable experience for all who attended. As a result, we have since purchased 8 canoes and plan on a second trip for early next summer. The next

journey will take us from the Racine Lake campground, back to the Chapleau River, and up to the Schewabik where we will have a cultural camp. Hopefully this will be an annual event, that will grow in attendance each year. We hope to see you all there!



Our powwow was a success this year, and I want to say "chi miigwetch" to all who helped and attended. Also in August, we held another Ancestry Feast, this time recognizing the summer season. This was a really great ceremony, which was attended by not only members of Chapleau Cree, but a couple staff members of Maamwesying, and a couple members from Brunswick House First Nation, which was really beautiful to see. Also, Malcolm McCormick of Maamwesying received a Spirit Name from Jules Tapas in a sweat ceremony. Congratulations Malcolm!

And finally, now that the cold season is returning, we will be returning with our

regularly scheduled 'Indigenous Movie Nights' and Youth Drumming practices, that took a short break over the summer months. Please see the monthly calendar for schedules. Also, feel free to contact me at the band office at any time for any questions, concerns, or suggestions for upcoming cultural events.
